Confidentiality Agreement

Because of the confidential nature of the work of the Pastoral Search Committee, I, _____ agree to keep confidential all information—whether it be written or verbal—while working on behalf of Resurrection Metropolitan Community Church (herein referred to as “Resurrection MCC” and “the Church”). This includes meetings, telephone conversations, text messages, emails, other messaging services and personal contact. As a member of the Pastoral Search Committee, I will not disclose the discussions, deliberations, or processes of the Pastoral Search Committee with anyone outside the Pastoral Search Committee, with the exception of the appropriate Elder(s) and any others as determined by the Chair. I will hold the other members of the Pastoral Search Committee accountable for such confidentiality, and I understand that any member who breaches this confidentiality agreement will be removed from the Pastoral Search Committee.

I further agree to hold the names and identifying characteristics of any candidate (e.g., age, race, gender identity, sexual orientation, geographic location, etc.) in the strictest confidence and I will not share this information with anyone outside the Pastoral Search Committee, with the exception of the appropriate Elder(s) and any others as determined by the Chair. I also understand and agree that the confidentiality of the information, which I learn by virtue of my Pastoral Search Committee duties and responsibilities, is vital to the continued success of Resurrection MCC. As such, I agree that I shall never directly or indirectly divulge, disclose, or communicate any confidential church information to anyone, without the prior consent of the Board of Directors. Such confidential church information includes information concerning church finances, executive decisions, counseling, compensation of staff, compensation of voluntary staff, church income, discussions with the staff, or any other matters affecting or relating to the business or leadership of the Church where the information is not specifically previously known to the persons to whom the information is being divulged, disclosed, or communicated.

Disclosure: Breach of this agreement may subject the responsible Pastoral Search Committee member to immediate dismissal from the Pastoral Search Committee and/or legal liability. The confidentiality requirements of this agreement shall remain in effect forever, unless revoked on behalf of the Church by the Board of Directors.
